
This letter supersedes any prior release agreement and confirms that you have completed both the three or four-day *Infinite Possibilities: Train the Trainer* program (the "Program") and Mike Dooley's *Playing the Matrix* program with trainer add-on, and accordingly, shall represent our Certification of you to train other people in the methods and principles comprising the Programs. Your authority to identify yourself as a Certified Trainer for *Infinite Possibilities* and *The Matrix* is subject to your agreement to the terms and conditions contained in this letter.

1. You may identify yourself as a Certified Trainer in the Programs in your biography, business cards and related materials.
2. You acknowledge that you are not an employee, agent or authorized representative of Tut Enterprises, Inc., including Tut.com and Tut's Adventurer's Club, and/or Mike Dooley (collectively, "Tut"), and you agree not to represent yourself as such. As between you and Tut, you shall be solely responsible for all costs and expenses incurred by you in offering training services.
3. We hereby grant to you the non-exclusive right to teach the methods and ideas presented in the Programs, which does not extend to Mike Dooley's other programs, materials, books, ideas, etc. If in doubt, please contact us and be guided by the usage instructions provided by us.
4. You shall respect the copyright in Mike Dooley's books and in Tut's other materials. Your *Infinite Possibilities* license term will extend for the life of this program, subject to the terms of this agreement being met and any future, modest renewal requirements as may be required. Your Matrix license term is 2 years, with automatic renewal unless the program is terminated for any reason, with 12 months advanced notice, without cost or reimbursement to you.
9.
